



**REFUND POLICY**

The final deadline for withdrawal from any LPI program is 14 days prior to the departure date of the program. If a student withdraws after this final deadline, no refund will be given, regardless of the reason for withdrawal. All withdrawal requests must be submitted in writing by the student or parent/guardian. If a student withdraws from the program prior to this final deadline for withdrawal, the LPI refund policy is as follows:

- A** If the student withdraws from the program on or before the application due date appearing in the LPI catalog/website, the deposit less \$150 is refundable. This applies to all students, regardless of the reason for withdrawal.
- B** If the student withdraws from the program after the application due date but prior to the payment due date appearing in the LPI catalog/website, LPI will refund all but \$200. This applies to all students, regardless of the reason for withdrawal.
- C** If the student withdraws 1-9 days after the payment due date appearing in the LPI catalog/website, LPI will refund all but \$750 plus any costs incurred by LPI on behalf of the student.
- D** If the student withdraws 10-20 days after the payment due date appearing in the LPI catalog/website, LPI will refund all but \$1,000 plus any costs incurred by LPI on behalf of the student.
- E** If the student withdraws 21 or more days after the payment due date appearing in the LPI catalog/website, but prior to the final deadline for withdrawal, LPI will refund all but \$1,500 plus any costs incurred by LPI on behalf of the student.

Signing and returning all documents in the acceptance packet is the student's responsibility. If a student fails to return the documents after repeated notification (email or call), he/she will be deemed withdrawn and will not be eligible for any refund. If a student changes or defers to another LPI program after the payment due date but prior to the final deadline to withdraw, LPI will assess a \$500 change fee plus costs incurred. Program changes are not permitted 1-14 days prior to the start of the program.

**PROGRAM WITHDRAWAL PROTECTION**



LPI's Program Withdrawal Protection guarantees a full refund of the program cost less the deposit and withdrawal protection fee under any circumstance provided that withdrawal is completed prior to the program's departure date. The cost for the LPI Program Withdrawal Protection is dependent upon a program's length.

Participants can purchase the LPI Program Withdrawal Protection any time before the application due date of their particular program. If a participant signs up for an LPI program after the application deadline, the Program Withdrawal Protection will be available for purchase for five business days after the program fee and late fee are received by LPI. All applications submitted within fourteen days of a program's departure date will not have the option to purchase the Program Withdrawal Protection.

Please note that any decision to withdraw from an LPI program on or after that program's departure date will result in no refund. Furthermore, all late fees incurred by the applicants, as well as all airfare purchases (whether made through LPI or independently), are excluded from the Program Withdrawal Protection.
